Request to Review or Inspect Ballot Materials

2026 Primary Election

Pursuant to F.S. 101.572(2), a candidate, a political party official, or a political committee official, or an authorized designee thereof, shall be granted reasonable access upon request to review or inspect ballot materials before canvassing or tabulation, including voter certificates, mail ballot envelopes, cure affidavits, corresponding comparison signatures, duplicate ballots, and corresponding originals.

For access to review or inspect ballot materials from the Supervisor of Elections, check the applicable authorization category, and submit this completed form. I am:

- A Candidate, must be a qualified candidate in the specific election requested**
- A Political Party Official, must be a registered political party in Florida**
- A Political Committee Official, must be a registered political committee in Florida**

Review/Inspection Guidelines

- The use of cell phones, photography, and ink pens are prohibited inside the designated review areas.
- **ONLY ONE PERSON** on behalf of each candidate, political party, or political committee is permitted to review or inspect ballot materials at each appointment.
